The participating district agrees to pay costs of all services determined as follows: All students entered on the teacher's monthly attendance reports as enrolled in the NCOESC Adapted Physical Education program will be totaled, and that figure will be used as the "divisor into the total program costs" figure to obtain the cost per pupil for any monthly bill back to the participating school districts. Attendance figures will be for the time period August through May, with invoices being issued monthly from September through June.

*The **estimated** FY26 cost for the Tiffin City School based on current program enrollment would be \$3,198.00 per student.*

*The total cost will vary based on number of students receiving services.*

Invoices will be issued on a monthly basis and will be payable upon receipt.
