Dear Mr. Williamson:

This letter serves as confirmation of the agreement between the Hopewell-Loudon Local School District and the Tiffin City School District regarding the continued educational placement of [REDACTED] (Date of Birth: [REDACTED]).

[REDACTED] is a resident student of the Hopewell-Loudon Local School District and remains entitled to attend Hopewell-Loudon as his district of residence pursuant to Ohio law. [REDACTED] has been a Hopewell-Loudon resident since March 2026, and currently receives special education services pursuant to an Individualized Education Program (IEP) that is being successfully implemented within Tiffin City Schools. Both districts recognize that maintaining [REDACTED] current educational placement provides continuity of programming and supports his educational needs in the least restrictive environment. Accordingly, the districts agree to the following:

1. [REDACTED] shall be permitted to continue attending Tiffin City Schools for the 2026-2027 school year.
2. Hopewell-Loudon Local School District shall provide transportation for [REDACTED] to and from Tiffin City Schools during the term of this agreement, if requested.
3. [REDACTED] shall be included in the Tiffin City School District's student enrollment count for purposes of state foundation funding. Tiffin City School District shall invoice Hopewell-Loudon Local School District on a quarterly basis for educational costs incurred in excess of the state foundation funding received on behalf of the student. Hopewell-Loudon shall remit payment within thirty (30) days of receipt of each invoice.
4. This agreement shall be effective for the 2026-2027 school year unless otherwise modified by mutual written agreement of both districts.
