Mr. Greg Williamson, Interim Superintendent

Minutes:

Mr. Greg Williamson said interviews for Director of Teaching and Learning would take place in the coming week. There are 27 applicants for Director of Community Engagement.

Regarding his 90 day plan, Mr. Williamson said he plans to meet with Mr. Mike Spafford to assess district technology needs. He said by the end of June, he intends to look at the district's current fiscal health plan and what future needs might be. He also hopes to have a good candidate for treasurer by that time. Mr. Williamson said he intends to form a permanent improvement planning committee.

Mr. Williamson told the Board the policy updates with Neola continue. Mr. Perez asked about policy regarding athletic transfers. He suggested educating 6th grade parents about the policy because it affects 7th and 8th grade student athletes. Mr. Perez asked if the updated policy would address neighboring school districts that don't have sports.
